



# CONTRACT AGREEMENT

## Scope of Work

COACHING-CORNER WARRANTS THAT THE SERVICE UNDER THIS AGREEMENT WILL BE EXECUTED IN A TIMELY MANNER MEETING OR EXCEEDING THE STANDARDS FOR SIMILAR WORK IN CLIENT'S COMMUNITY OR REGION AND WILL COMPLY WITH ALL APPLICABLE REQUIREMENTS.

## Cancellations

Should the client cancel the appointment within 24 hours of their scheduled appointment, unless the cancellation is due to extenuating circumstances (such as death, illness, or any other incapacitating act), the client will be responsible for full payment.

## Termination

This agreement will terminate on conclusion of appointment.

Coaching-Corner will be entitled to full compensation for work completed prior to the effective termination date. This payment obligation, and any payment obligations pending at termination, shall survive termination.

## Miscellaneous

This agreement is between the Client and Coaching-Corner and neither is allowed to delegate, transfer or assign it to a third party without the written consent of the other.

This is the parties' entire agreement on this matter, superseding all previous negotiations or agreements. It can only be changed by mutual written consent.

The laws of the state of Michigan govern this agreement and any disputes arising from it must be handled exclusively in courts in the state of Michigan. The prevailing party in any dispute will be entitled to recover reasonable costs and attorneys' fees.
